This is regarding to carry out the preparatory exercise for GDS Online engagement, Schedule-I, January-2025.

2. In this context, it has been decided to issue notification of vacancies under the GDS Online Engagement, Schedule-I (January), 2025 in the last week of January- 2025 and following timelines have been prescribed for completing preparatory activities, as noted below:

3. For the purpose of vacancies calculation, the following vacancies would be included/excluded by the Circle: -

- (b) Unfilled vacancies of Schedule, July-2024, including vacancies on which the candidate had turned up to the EA but not joined within 30 days of period except those in pipeline as per sub Para (c) below. The unfilled vacancies of Schedule-II, July-2023 and Special Drive, May-2023 for
